They are directed to report for duty to the Medical Superintendent, A.B.V.R.C.C, Agartala within 7 (seven) days of issuance date of Notification.

Terms and Conditions as per the Notification of Health Family Welfare Department, Govt. of Tripura vide No. F. No. 4(7-95)-AGMC/Academic/JR (Non Academic)/ 2019/551-8290 dt. 13th January, 2022:

- Candidates selected should join within 07 (seven) days of issuance of appointment letter failing which the respective post/posts will be treated as vacant.
- The engagement shall be purely on temporary and tenure basis. Initial appointment will be for 11 (eleven) months which may be continued upto a maximum of 03 (three) years on the basis of performance.
- Candidates selected must perform JR ship for at least 06 (six) months failing which no further continuation / appointment to the post of JR (non academic) will be considered.
- Experience Certificate for JR ship can be claimed only after completion of 06 (six) months.
- A candidate can resign from the post of JR (Non academic) only with 15 (fifteen) days prior written intimation through proper channel.
- The terms of appointment will be treated as terminated if any candidate remains absent un-authorizedly.

- Those who joined Junior Residency (Non-Academic) at A.G.M.C, I.G.M.H & A.B.V.R.C.C and whose services were terminated on account of unauthorized absence shall not be eligible for subsequent selection.
- The JR (Non Academic) whose tenure is terminated for any reason by the authority will be debarred from being selected as JR (Non Academic) for next three years.
- The authority deserves the right for placement of JR to any discipline at any time as per need of the institution.
- **Pay:** Consolidated pay of Rs. 35,000/- per month on submission of Working Certificate of the Junior Resident (Non Academic) issued by Head of the concerned Departments, A.G.M.C & G.B.P Hospital, I.G.M Hospital and A.B.V.R.C.C, Agartala.

Leave: The Junior Residents (Non-Academic) are entitled to 15 days leave during six months at the rate of 2½ days leave for every completed month and not more than 10 days leave can be availed at a time including Sundays and holidays. The Head of the Department shall be the sanctioning authority for any such leave.
