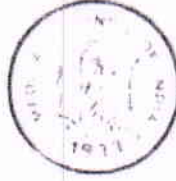

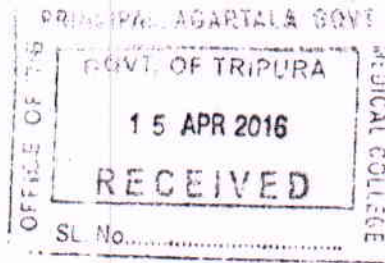

Sub: Tripura University - Recognition of MS(General Surgery) qualification for 02 seats in respect of students being trained at Agartala Govt. Medical College, Agartala, Tripura.

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 30/03/2016 considered the Compliance Verification Assessment (29/02/2016) along with the Council Assessor's Report (May, 2014) and compliance dated 11/08/2015 submitted by the college authorities on the physical and other teaching facilities available at Agartala Govt. Medical College, Agartala, Tripura for the award of MS(General Surgery) qualification for 02 seats under Tripura University. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment (29/02/2016) along with the Council Assessor's Report (May, 2014) and compliance dated 11/08/2015 submitted by the college authorities and decided to recommend to the Central Government that MS(General Surgery) qualification for 02 seats granted by Tripura University in respect of students being trained at Agartala Govt. Medical College, Agartala, Tripura be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
