
Sir/Madam,

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition against increased intake of 01 to 03 seats & Renewal of Recognition of 01 seat of MD(Microbiology) qualification in respect of students being trained at Agartala Govt.
